Executive Director's Report / Operations Director's Report **September 17th 2014**

Monthly Activity Statistics (June 1, 2014-July 31, 2014)

6490 911 calls / 3107 dispatched emergencies

Employee Issues / Training / Lead Telecommunicator

It has been decided to increase the frequency of the QA reviews to twice each month for each employee. While we have been getting good data and areas of improvement have been identified, it is imperative that we strive for standardization and consistency with all call processing and dispatching functions throughout the workforce.

911 Commission / Regional Updates

DSET has issued their proposed funding modifications and along with our Regional partners we are reviewing the new language. While an initial review indicates a possible \$50,000 loss of yearly revenue to TN, other centers are facing much larger reductions. It is still very early in the process and plans are being formulated to establish alternative suggestions.

The new 911 call processing platform is due to be installed in the test centers prior to the end of the year. Once all the performance issues are corrected, the statewide deployment will begin.

Communications Truck / TN Presentations

It has been relatively quiet and the truck has not been deployed in the past few months. Radio channels continually are upgraded and issues found with the vehicles are corrected.

UCONN Tower Site

We are in the final stages of gaining the proper approvals for placing equipment on the UCONN Tower. This will certainly provide stellar coverage within our dispatch area. Once the equipment is installed there will be a significant testing period to evaluate the effectiveness within the County.

State Technical Advisory Committee

We have obtained approval from State Tech to proceed with the procurement for the UCONN site as well as the replacement of a low band and VHF base located at the Union tower site.

Website

The new website is operational. It will continue to be a work in progress, and if any department has anything newsworthy that they would like posted please send the submission to Tyler or Stuart. We plan on having a section added for the exclusive posting of training classes / EMS recerts etc. There are a few documents that we felt important to have on the site for everyone's convenience which are in the member's only section. I will let everyone know the username and password to the restricted page at the meeting. The EOP, contact information for the Chiefs and other pertinent documents are located on this page.

Other

- As previously reported we were successful with the bond request for the new radio console. We have been in touch with DECD as they are administering the grant. We are navigating through the necessary paperwork and working with the selected vendor to procure the system.
- All radio systems are functioning normally. We are working on reprogramming some of the cross band repeater sites with new DTMF tones to alleviate the errant changing of channels. We have identified a method to correct this and must visit each site to make the modifications.
- We have had a few activations of the Capital Region Task Forces which have gone well from our end. The command board that was purchased for us is ready to be shipped.
- We are working on establishing a console to console patch between TN and Coventry PD, Vernon PD and UCONN PD. This link will alleviate phone calls back and forth during an emergency and allow for quick exchanges of information via secure radio link.
- We continue to work with various entities on fulfilling FOIA requests which have been rather laborious.

- The CMED Centers Group has been very active as there is significant movement in Southern CT to move away from the concept and explore other avenues due to fiscal restraints. We are watching this very closely as any modifications to the regulations by OEMS/DPH could have an effect on us here at TN.
- Reminder of the Convention this weekend. If you are attending the Convention with any apparatus please see and adhere to the guidance attached to this report.

IT topics / Report from Systems Administrator

- Considerable time has been spent with NWS as they are actively working on the interface to Avtec.
- We have a quote from our recorder vendor for the modifications required for the new Avtec system. We have to convert to IP vs analog channel recording capability.
- Several weeks were spent assembling over 2,000 hydrants, dry hydrants, and water supply locations from 13 towns into one mapping layer. We still have to move them into the CAD but we're getting closer.
- After meeting with representatives from Lifestar & Fleeteyes, our dispatchers now have the ability to see the location and status of each Lifestar helicopter updated every 60 seconds.
- As always, we continue to monitor any unverified addresses, update run cards, check cross streets for all outgoing pages, review our CAD map against other data sources, and add/change cell phone paging info, officer lists.
- Upcoming/continuing projects – Keep working on the hydrant data, get the Powerphone EMD software application installed

ALL State Convention Parade Invitees

The Connecticut State Fire Disaster Plan will be coordinating communications and tracking of all with Fire and Emergency equipment moving to Litchfield to participate in this year's Convention Parade. Please help us communicate with and track vehicles while testing statewide communications.

Quite simply, Departments are asked to "sign on" when leaving their stations or quarters for the parade, just as they would when responding to a disaster. In addition to any local radio communications (i.e. to your local dispatch center) we ask that you also use the Statewide inter-agency radio system (8-Call/8-Tac, formerly known as I-Call/I-Tac) and sign on with "convention staging" to let the Incident Staging Officer know you are **enroute** on, if you have the capability:
